I, Kellyn Timmerman, declare:

- 1. I have personal knowledge of the facts set forth in this declaration.
- 2. I have worked as a Postmates driver in the San Diego County, California area since on or about May 25, 2017 until the present date.
- **3.** On a typical day, I drive for Postmates from around 11:00 a.m. until 6:00 p.m. I work approximately seven days a week. On average, I have worked 49 hours a week for Postmates.
- **4.** During this time working for Postmates, I have leased two Toyota Prius which I used to make deliveries.
- 5. The types of restaurants I make deliveries for vary a lot. It was more diverse in the first year to year and a half, when the restaurants ranged from fast food to 5-star restaurants. During the last year or so, it is still a range of anything from fast food to larger chains like Tender Greens and Chipotle and to smaller, local businesses. These would include liquor stores and 7-Elevens. I have also made "shopping" deliveries from Target, Trader Joe's, Ralphs, and a pet store, to name a few examples.
- **6.** My job consists of picking up (sometimes picking up and paying, and sometimes even ordering, paying, waiting for the product and picking up). Then I deliver the items to the customers at their homes, apartments, high-rises, commercial office buildings, hotels, hospitals, etc.
- 7. I usually accept every order I received but even if I declined it or wanted to decline, which was my understanding was within my right, Postmates would automatically add that delivery location and order to my account and if I didn't make the delivery or wanted to cancel, they would cancel my current orders as well. At the beginning I would only be able to know the pick-up location of the order but not the drop-off. Afterwards, this changed, letting us know the close vicinity of the drop-off.
- **8.** I am paid per delivery. When I started working for Postmates, my base pay was around \$4.80 per delivery. Now, my base pay is \$3.00 per delivery because of changes in Postmates' policies.

**9.** I have not received compensation of any kind in exchange for the general release of my claims against Postmates, other than the proposed service award I would receive as part of this settlement.

I declare under the penalty of perjury under the laws of the State of California that the foregoing is true and correct to the best of my knowledge.
